

Appended Documents

- No appended documents are required for items delivered within the EU.
- Appended documents for customs clearance are required for goods delivered outside the EU. If the country of destination requires more than one customs declaration, the missing number of customs declarations (CN 23) must be completed.
- A commercial invoice or pro forma invoice is required for goods sent for commercial purposes.
- For information on any necessary appended documents and the related rules and regulations, are available at www.posti.fi.

Limitations on Contents

- The contents must be airworthy.
- Please check country-specific limitations and regulations on the transport of dangerous substances and other restricted items at www.posti.fi.

- When sending items using the online sending service, some of the countries are included in the Parcel Connect tariff zones.
