- Appended documents for customs clearance are required for goods delivered outside the EU. If the country of destination requires more than one customs declaration, the missing number of customs declarations (CN 23) must be completed.
- A commercial invoice or pro forma invoice is required for goods sent for commercial purposes.
- More information regarding the appendix documents and stipulations related to them is available online.

Limitations on Contents

- The contents must be airworthy.
