

Prices are valid from January 1, 2021 and Express Freight prices from October 1, 2020.

The pricing of parcels is based on units and the mailed item's measured weight or volume, whichever is the greater. The cubic measure used for parcels is 1m³ = 250kg. The minimum pricing weight is 100g.

The maximum batch size for multi parcel shipments is 10 items.

The pricing of Express Freight is based on the transport unit type, the size of the shipment lot, transport distance, and the additional service used.

Unless otherwise stated, the prices include transport from a Posti outlet to the recipient or pick-up location. A pick-up can be ordered for items (subject to a separate charge), or a pick-up and delivery contract can be signed with Posti.

An applicable fuel surcharge will be charged separately. The fuel surcharge is based on the Fuel Factor of Statistics Finland's cost index on the road transport of goods, and it will be reviewed every month, on the first Monday of each month. The surcharge shall be applied to domestic and international parcel and freight services. The currently valid fuel surcharges are specified on Posti's website on page [www.posti.fi/fuelsurcharge](http://www.posti.fi/fuelsurcharge).

**Value added tax**

The tariffs and rates are quoted excluding VAT, unless otherwise stated. VAT valid at the time will be added to prices during invoicing.

No VAT is added to the tariffs and rates applying to mail addressed to the Åland Islands, special areas outside the European Union's excise and VAT zone and non-EU member states.

## Modifications to Information of an Item Already Sent

1139

Posti is entitled to collect charges for modifications to an item already sent.

By request of sender

- change of addressee's name/address
  - altering the COD amount
  - altering the account number (domestic service only)
  - requesting the item's withdrawal
  - altering a term of delivery (cancelling / adding delivery to addressee in person)
  - delivering an item, originally collectable from the postal outlet, to the recipient (for domestic service only)
  - enabling the recipient to check the item's content before taking delivery of the item at the postal outlet (domestic parcel service only)
  - prolonged storage time for parcels up to 14 calendar days (for domestic parcel service only)
- are subject to a charge of **EUR 14.66 /alteration**.

The customer will be notified as to whether the service has been successfully performed with respect to requests for changes to domestic services.

## Charges for Other Tasks 2129, 3305, 10958

- Posti may collect a charge for additional work not included in the service.

## DIMENSIONS

The maximum weight for all parcels is 35kg and the maximum size is 120 x 60 x 60cm, or 300 x 120 x 60cm for Oversized parcels. Exceptions to this are Postal Parcel, the maximum size of which with the Oversized additional service is 180 x 80 x 60cm, and Posti Small Parcel, the maximum weight of which is 2kg and maximum size 3 x 25 x 35cm.

The minimum size for all parcels is 1 x 15 x 15cm.

Parcels up to 59 x 60 x 36cm can be sent to a Posti Parcel Locker.
